### **Our use of collected data**

#### **Collecting data**

We collect data if you:

- makes a booking request
- book directly with LOTT holiday homes & more
- sign up for the newsletter

We only use the data that you provide to us. This can be the following data:

- your first and last name
- possibly. the first and last names of your fellow traveler(s)
- your e-mail adress
- your address
- your phone number
- Amount of adults
- number of children
- possibly. dates of birth

We need this information to properly handle and answer your request.

What do we use the data for?

The data is collected and stored for the following purposes:

- We need the reservation request with the requested information to check the availability of a suitable holiday home for you.
- We use your name and email address to send newsletters. This only happens with the data we have received through requesting a booking and/or registering for the newsletter

### **Information we store**

This is the data we store:

- Your first and last name
- Your address, zip code and place of residence, so that we can send the booking confirmation to the right person and to the right address as quickly and easily as possible.
- Telephone number, in order to be able to inform you about your request or to pass on changed information about your holiday home at the last minute. Sometimes it is more convenient to do this by telephone. You are never obliged to fill it in.
- Email address, because as soon as we have received your request for a holiday home, you will receive a confirmation by email.

### **Your data and the systems that process it**
